



**Announcement of King Mongkut's University of Technology Thonburi  
Measure and Surveillance of Coronavirus Disease (COVID-19) Outbreak  
No. 28  
Request for cooperation to avoid traveling to risk areas**

With reference to the Announcement of King Mongkut's University of Technology Thonburi (KMUTT) on the Measure and Surveillance of Coronavirus Disease (COVID-19) Outbreak No. 27, dated April 9, 2021 regarding the temporary closure of King Mongkut's University of Technology Thonburi and measures for class management and university operation during the outbreak of COVID-19, the University has observed the situation and recognized that the outbreak situation in Thailand will continue to escalate. In this connection, by the virtue of Section 24 and Section 27 of the King Mongkut's University of Technology Thonburi ACT B.E.2541, the University thus issued this Announcement to request cooperation from students and staff. The detail are as follows:

1. The University requests all students and staff who are currently conducting their online studies and working at their residence (Work from Home) to avoid travelling to the risk-prone areas of COVID-19 transmission such as night entertainment venues, service facilities, crowded places, and to refrain from organizing or joining parties.
2. The University requests for cooperation from students and staff to use the "MorChana" mobile application for their own safety and COVID-19 prevention.
3. Students and staff are recommended to follow the "New Normal" life style which includes wearing face mask, keeping 1 metre physical distancing, frequently washing their hands, and refraining from sharing their foods with others.
4. Students and staff who have been in close contact with the COVID-19 infected person(s) or have a symptom that could indicate COVID-19, please undergo self-quarantine according to the authorities' requirement. In case that you have COVID-19 symptoms, please go to the hospital in the insurance company's network. Students and staff can contact the COVID-19 Emergency Operation and Assistance Center (KMUTT COVID-19 Center) via 24-hours hotline number at 02 4709090 or report the case at <http://bit.ly/Wereport>. The University will further coordinate with the related person on the management of COVID-19 insurance coverage.
5. Students and staff shall strictly comply with COVID-19 preventive measures prescribed by the University. Any act of intentionally distorting, concealing and giving false information to their supervisors to violate this announcement may result in disciplinary action.

6. If there is any problem or issue arising from this announcement, the Senior Vice President for Administrative Affairs who is in charge of COVID-19 Emergency Operation and Assistance Center of KMUTT is tasked with deliberating and executing any action deemed appropriate and reporting the President accordingly.
