King Mongkut's University of Technology Thonburi:

The surveillance of COVID-19 outbreak

No. 83 on August 7, 2021

On August 7, 2021, the University was reported 14 COVID-19 confirmed cases as follows:

The first case is a male undergraduate student from the Department of Mathematics, Faculty of Science **(the 227th case of KMUTT)**. Currently, he is receiving medical treatment at home (Home Isolation Program) under the care of a government hospital. The student reported that he hasn't entered the University premises (KMUTT Bangmod Campus) and hasn't done any activities with other students or staff. The related units are currently investigating to identify people whom the infected student might be in close contact with to assess the level of risk and continue to operate the relevant practices according to the measures of the Department of Disease Control.

The second case is a female undergraduate student from the Department of Printing and Packaging Technology, Faculty of Industrial Education and Technology **(the 228th case of KMUTT)**. The student reported that she has fully recovered from COVID-19 after being hospitalized for treatment in the government hospital. Currently, she is undergoing 14-day self-quarantine at home. The student reported that she hasn't entered the University premises (KMUTT Bangmod Campus) and hasn't done any activities with other students or staff. The related units are currently investigating to identify people whom the infected student might be in close contact with to assess the level of risk and continue to operate the relevant practices according to the measures of the Department of Disease Control.

The third case is a female undergraduate student from the Department of Mathematics, Faculty of Science **(the 229th case of KMUTT)**. Currently, she is waiting to be transferred to a government hospital for treatment. The student reported that she hasn't entered the University premises (KMUTT Bangmod Campus) and hasn't done any activities with other students or staff. The related units are currently investigating to identify people whom the infected student might be in close contact with to assess the level of risk and continue to operate the relevant practices according to the measures of the Department of Disease Control.

The fourth case is a male undergraduate student from the Joint Management Program, Media Arts and Media Technology, School of Architecture and Design **(the 230th case of KMUTT)**. Currently, he is undergoing the Home Isolation Program. The student reported that he hasn't entered the University premises (KMUTT Bangmod Campus) and hasn't done any activities with other students or staff. The related units are currently investigating to identify people whom the infected student might be in close contact with to assess the level of risk and continue to operate the relevant practices according to the measures of the Department of Disease Control.

The fifth case is a male master's student from the Graduate School of Management and Innovation **(the 231st case of KMUTT)**. Currently, he is undergoing the Home Isolation Program. The student reported that he hasn't entered the University premises (KMUTT Bangmod Campus) and hasn't done any activities with other students or staff. The related units are currently investigating to identify people whom the infected student might be in close contact with to assess the level of risk and continue to operate the relevant practices according to the measures of the Department of Disease Control.

The sixth case is a male undergraduate student from the Department of Electrical Engineering, Faculty of Engineering **(the 232nd case of KMUTT)**. Currently, he is undergoing the Home Isolation Program. The student entered the University premises (KMUTT Bangmod Campus) only on June 15, 2021. He wore a face mask all the time and wasn't in close contact with other students or staff. Except for that day, he hadn't visited the University and hadn't done any activities with other students or staff. The related units are currently investigating to identify people whom the infected student might be in close contact with to assess the level of risk and continue to operate the relevant practices according to the measures of the Department of Disease Control.

The seventh case is a female undergraduate student from the Department of Mechanical Technology Education, Faculty of Industrial Education and Technology **(the 233rd case of KMUTT)**. The student reported that she has fully recovered from COVID-19 after being hospitalized for treatment in the government hospital. Currently, she is undergoing 14-day self-quarantine at home. The student reported that she hasn't entered the University premises (KMUTT Bangmod Campus) and hasn't done any activities with other students or staff. The related units are currently investigating to identify people whom the infected student might be in close contact with to assess the level of risk and continue to operate the relevant practices according to the measures of the Department of Disease Control.

The eighth case is a female undergraduate student from the Department of Chemical Engineering, Faculty of Engineering **(the 234th case of KMUTT)**. She is currently waiting to be transferred to a private hospital for treatment. The student reported that she hasn't entered the University premises (KMUTT Bangmod Campus) and hasn't done any activities with other students or staff. The related units are currently investigating to identify people whom the infected student might be in close contact with to assess the level of risk and continue to operate the relevant practices according to the measures of the Department of Disease Control.

The ninth case is a female undergraduate student from the Department of Chemical, Faculty of Science **(the 235th case of KMUTT)**. Currently, she is in a government hospital for treatment. The student entered the University premises (KMUTT Bangmod Campus) only on June 30, 2021. She wore a face mask all the time and wasn't in close contact with other students or staff. Except for that day, she hadn't visited the University and hadn't done any activities with other students or staff. The related units are currently investigating to identify people whom the infected student might be in close contact with to assess the level of risk and continue to operate the relevant practices according to the measures of the Department of Disease Control.

The tenth case is a female undergraduate student from the Department of Chemical, Faculty of Science **(the 236th case of KMUTT)**. Currently, she is receiving medical treatment at home (Home Isolation Program) under the care of a government hospital. The student entered the University premises (KMUTT Bangmod Campus) only on June 15, 2021. She wore a face mask all the time and wasn't in close contact with other students or staff. Except for that day, she hadn't visited the University and hadn't done any activities with other students or staff. The related units are currently investigating to identify people whom the infected student might be in close contact with to assess the level of risk and continue to operate the relevant practices according to the measures of the Department of Disease Control.

The eleventh case is a male staff member of the Office of Building and Ground Management **(the 237th case of KMUTT)**. Currently, he is receiving medical treatment at home (Home Isolation Program). The staff reported that he met his colleagues outside the University on July 28, 2021. The investigation revealed 1 staff member who is considered as a risk group. The University has given order the said staff member to undergo self-quarantine and work from home for 14 days. The infected staff entered the University premises (KMUTT Bangmod Campus) on July 30, 2021. He wore a face mask all the time and wasn't in close contact with other students or staff.

The twelfth case is a male staff member of the Treasury Office (**the 238th case of KMUTT**). He has already contacted the relevant government agencies, and is currently waiting for further response regarding his treatment program. The staff reported that he entered the University premises (KMUTT Bangmod Campus) on the following dates: July 12, July 14, July 16, July 19, July 21, July 23, and July 27, 2021. He wore a face mask all the time and keep distancing with other staff. The investigation revealed 1 staff member who is considered as a risk group. The University has given order the said staff member to undergo self-quarantine and work from home for 14 days.

The thirteenth case is a male staff member of the Graduate School of Management and Innovation (**the 239th case of KMUTT**). Currently he is in a private hospital for treatment. The staff reported that he entered the University premises (KMUTT Bangmod Campus) on July 21, 2021. He wore a face mask all the time and wasn't in close contact with other students or staff.

The fourteenth case is a female cleaning staff who works on the 6th floor of the Pilot Plant Development and Training Institute, KMUTT Bang Khun Thian Campus (**the 240th case of KMUTT**). Currently, she is receiving medical treatment at home (Home Isolation Program), and is waiting for further response from the government hospital regarding her treatment program. The related units are currently investigating to identify people whom the infected student might be in close contact with to assess the level of risk and continue to operate the relevant practices according to the measures of the Department of Disease Control.
