King Mongkut's University of Technology Thonburi: The surveillance of COVID-19 outbreak No. 182 on January 11, 2022

On January 11, 2022, the University was reported 11 COVID-19 confirmed cases as follows:

The first case is a male staff member of the Department of Mechanical Engineering, Faculty of Engineering (the 581st case of KMUTT). Currently, he is in a private hospital for treatment. The staff entered the University premises (KMUTT Bangmod Campus) on January 2–3, 2022. He kept physical distancing and wore a face mask all the time while visiting the university premises. The related units are currently investigating to identify people whom the infected staff might be in close contact with to assess the level of risk and continue to operate the relevant practices according to the measures of the Department of Disease Control.

The second case is a female staff member of KX Building (the Unit under supervision of the University) (the 582nd case of KMUTT). Currently, she is in a private hospital for treatment. The staff entered the University premises (KMUTT Bangmod Campus and KX Building) on January 7, 2022. She kept physical distancing and wore a face mask all the time while visiting the university premises. The investigation revealed 2 staff members who are considered as a risk group. Thus, the University has given order to the staff members who were considered as the risk group to work from their residence for 14 days.

The third case is a male staff member of the Joint Graduate School of Energy and Environment (the 583rd case of KMUTT). Currently, he is undergoing his treatment Program. The staff reported that he hasn't entered the University premises (KMUTT Bangmod Campus) and hasn't done any activities with other students or staff. The related units are currently investigating to identify people whom the infected staff might be in close contact with to assess the level of risk and continue to operate the relevant practices according to the measures of the Department of Disease Control.

The fourth case is a male undergraduate student from the Department of Computer Engineering, Faculty of Engineering (the 584th case of KMUTT). He has already contacted the relevant government agencies, and is currently waiting for further response regarding his treatment program. The student entered the University premises (KMUTT Bangmod Campus) on January 6, 2022. He kept physical distancing and wore a face mask all the time while visiting the university premises. The related units are currently investigating to identify people whom the infected student might be in close contact with to assess the level of risk and continue to operate the relevant practices according to the measures of the Department of Disease Control.

The fifth case is a female high school student of the SCiU Program, Darunsikkhalai School for Innovative Learning (DSIL) (the 585th case of KMUTT). Currently, she is in a private hospital for treatment. Her advisor reported that the student has neither visited DSIL nor KMUTT (Bang Khun Thian Campus), and hasn't done any activities with other students or staff since January 2022. The related units are currently investigating to identify people whom the infected student might be in close contact with to assess the level of risk and continue to operate the relevant practices according to the measures of the Department of Disease Control.

The sixth case is a female undergraduate student from the Media Technology Program, School of Architecture and Design (the 586th case of KMUTT). Currently, she is in a private hospital for treatment. The student reported that she hasn't entered the University premises (KMUTT Bangmod Campus and KMUTT Bang Khun Thain Campus) and hasn't done any activities with other students or staff since January 2022. The related units are currently investigating to identify people whom the infected student might be in close contact with to assess the level of risk and continue to operate the relevant practices according to the measures of the Department of Disease Control.

The seventh case is a female master's student from the Graduate School of Management and Innovation (the 587th case of KMUTT). Currently, she is in a private hospital for treatment. The student reported that she hasn't entered the University premises (KMUTT Bangmod Campus) and hasn't done any activities with other students or staff since January 2022. The related units are currently investigating to identify people whom the infected student might be in close contact with to assess the level of risk and continue to operate the relevant practices according to the measures of the Department of Disease Control.

The eighth case is a female master's student from the Graduate School of Management and Innovation (the 588th case of KMUTT). Currently, she is in a hospitel for treatment. The student reported that she hasn't entered the University premises (KMUTT Bangmod Campus) and hasn't done any activities with other students or staff since January 2022. The related units are currently investigating to identify people whom the infected student might be in close contact with to assess the level of risk and continue to operate the relevant practices according to the measures of the Department of Disease Control.

The ninth case is a female undergraduate student from the Department of Mathematics, Faculty of Science (the 589th case of KMUTT). Currently, she is in a hospitel for treatment. The student reported that she hasn't entered the University premises (KMUTT Bangmod Campus) and hasn't done any activities with other students or staff since January 2022. The related units are currently investigating to identify people whom the infected student might be in close contact with to assess the level of risk and continue to operate the relevant practices according to the measures of the Department of Disease Control.

The tenth case is a female staff member of the Department of Chemical Engineering, Faculty of Engineering (the 590th case of KMUTT). Currently, she is in a private hospital for treatment. The staff entered the University premises (KMUTT Bangmod Campus) on December 27–28, 2021. She kept physical distancing and wore a face mask all the time while visiting the university premises. The related units are currently investigating to identify people whom the infected staff might be in close contact with to assess the level of risk and continue to operate the relevant practices according to the measures of the Department of Disease Control.

The eleventh case is a male staff member of the Office of the President (the 591st case of KMUTT). Currently, he is in a hospitel for treatment. The staff entered the University premises (KMUTT Bangmod Campus) on January 5–7, 2022. He kept physical distancing and wore a face mask all the time while visiting the university premises. The investigation revealed 6 staff members who are considered as a risk group. Thus, the University has given order to the staff members who were considered as the risk group to work from their residence for 14 days.
