

Notice of King Mongkut's University of Technology Thonburi: The surveillance of COVID-19 outbreak No. 207 on February 5, 2022

On February 5, 2022, the University was reported 13 COVID-19 confirmed cases as follows:

The first case is a male staff member of the School of Information Technology **(the 809th case of KMUTT)**. Currently, he is in a hospital for treatment. The staff reported his timeline 14 days before diagnosed with COVID-19, he had neither entered the University premises (KMUTT Bangmod Campus) nor done any activities with other students or staff. The related units are currently investigating to identify people whom the infected staff might be in close contact with to assess the level of risk and continue to operate the relevant practices according to the measures of the Department of Disease Control.

The second case is a male staff member of the School of Architecture and Design **(the 810th case of KMUTT)**. Currently, he is in a hospital for treatment. The staff entered the University premises (KMUTT Bangmod Campus) on February 1, 2022. He kept physical distancing and wore a face mask all the time while visiting the university premises. The related units are currently investigating to identify people whom the infected staff might be in close contact with to assess the level of risk and continue to operate the relevant practices according to the measures of the Department of Disease Control.

The third case is a female staff member of the Institute of Field Robotics **(the 811th case of KMUTT)**. Currently, she is undergoing the Home Isolation Program. The staff reported that she hasn't entered the University premises (KMUTT Bangmod Campus) since January 2022. The related units are currently investigating to identify people whom the infected staff might be in close contact with to assess the level of risk and continue to operate the relevant practices according to the measures of the Department of Disease Control.

The fourth case is a female staff member of the Joint Graduate School of Energy and Environment **(the 812th case of KMUTT)**. Currently, she is in a private hospital for treatment. The staff reported that she hasn't entered the University premises (KMUTT Bangmod Campus) since January 2022. However, the investigation revealed 1 staff member who is considered as a risk group. Thus, the University has given order to the staff member who was considered as the risk group to work from their residence for 14 days.

The fifth case is a male undergraduate student from the Information Technology Program, School of Information Technology **(the 813th case of KMUTT)**. Currently, he is in a private hospital for treatment. The student reported that he hasn't entered the University premises (KMUTT Bangmod Campus) since January 2022. The related units are currently investigating to identify people whom the infected student might be in close contact with to assess the level of risk and continue to operate the relevant practices according to the measures of the Department of Disease Control.

The sixth case is a female undergraduate student from the Department of Chemical Engineering, Faculty of Engineering **(the 814th case of KMUTT)**. She has already contacted the relevant government agencies, and is currently waiting for further response regarding her treatment program in a hospital. The student reported that she hasn't entered the University premises (KMUTT Bangmod Campus) since January 2022. The related units are currently investigating to identify people whom the infected student might be in close contact with to assess the level of risk and continue to operate the relevant practices according to the measures of the Department of Disease Control.

The seventh case is a male undergraduate student from the Joint Management Program, Media Arts and Media Technology, School of Architecture and Design **(the 815th case of KMUTT)**. Currently, he is in a hospital for treatment. The student reported that he hasn't entered the University premises (KMUTT Bang Khun Thian Campus) since January 2022. The related units are currently investigating to identify people whom the infected student might be in close contact with to assess the level of risk and continue to operate the relevant practices according to the measures of the Department of Disease Control.

The eighth case is a male master's student from the Department of Chemical Engineering, Faculty of Engineering **(the 816th case of KMUTT)**. Currently, he is in a hospital for treatment. The student entered the University premises (KMUTT Bangmod Campus) on January 10, 2022. He kept physical distancing and wore a face mask all the time while visiting the university premises. The related units are currently investigating to identify people whom the infected student might be in close contact with to assess the level of risk and continue to operate the relevant practices according to the measures of the Department of Disease Control.

The ninth case is a male undergraduate student from the Department of Mechanical Engineering, Faculty of Engineering **(the 817th case of KMUTT)**. Currently, he is in a hospital for treatment. The student reported that he hasn't entered the University premises (KMUTT Bangmod Campus) since January 2022. The related units are currently investigating to identify people whom the infected student might be in close contact with to assess the level of risk and continue to operate the relevant practices according to the measures of the Department of Disease Control.

The tenth case is a male master's student from the Information Technology Program, School of Information Technology **(the 818th case of KMUTT)**. Currently, he is in a private hospital for treatment. The student reported that he hasn't entered the University premises (KMUTT Bangmod Campus) since January 2022. The related units are currently investigating to identify people whom the infected student might be in close contact with to assess the level of risk and continue to operate the relevant practices according to the measures of the Department of Disease Control.

The eleventh case is a male master's student from the Department of Mathematics, Faculty of Science **(the 819th case of KMUTT)**. Currently, he is in a hospital for treatment. The student reported that he hasn't entered the University premises (KMUTT Bangmod Campus) since January 2022. The related units are currently investigating to identify people whom the infected student might be in close contact with to assess the level of risk and continue to operate the relevant practices according to the measures of the Department of Disease Control.

The twelfth case is a male undergraduate student from the Department of Civil Technology Education, Faculty of Industrial Education and Technology **(the 820th case of KMUTT)**. The student reported that he has fully recovered from COVID-19 after being hospitalized for treatment in a private hospital. The student reported that he hasn't entered the University premises (KMUTT Bangmod Campus) since January 2022. The related units are currently investigating to identify people whom the infected student might be in close contact with to assess the level of risk and continue to operate the relevant practices according to the measures of the Department of Disease Control.

The thirteenth case is a male staff member of the School of Information Technology **(the 821st case of KMUTT)**. Currently, he is in a private hospital for treatment. The staff entered the University premises (KMUTT Bangmod Campus) in January 2022. He kept physical distancing and wore a face mask all the time while visiting the university premises. The investigation revealed 3 staff members who are considered as a risk group. Thus, the University has given order to the staff members who were considered as the risk group to work from their residence for 14 days.
